Madam/Sir,

With reference to the subject cited above, I am directed to say that all valid and eligible research publications of medical college teachers belonging to the OMES cadre (a list of eligible faculty members is enclosed) are required for the purpose of promotion and ensuring timely career advancement. The publications submitted by the faculty members should adhere to the Minimum Qualifications for Teachers' Eligibility in Medical Institutions regulations, as outlined by the National Medical Commission (NMC) on February 22, 2022. Additionally, faculty members are required to attach certificates of completion for basic courses in Biomedical Research and Medical Education and Technology from institutions designated by the NMC or the latest Dental Council of India guidelines. Furnishing any incorrect or falsified proof of index by the faculty members will be considered forgery and will result in punitive action against such faculties.

The Dean and Principal of the Medical College and Hospital (MCH) is hereby requested to evaluate and assess the received publications by a Committee constituted at the MCH level, following the aforementioned regulations, and submit only the valid and eligible ones to this Directorate on or before **Dtd:** 19.08.2023 via email: tbcadmet@gmail.com in the enclosed format for further verification at this end. The MCH-level Committee will be held accountable for any submission of non-valid or non-eligible publications to this Directorate. The Dean and Principal of the concerned college are directed to furnish hard copies of the duly evaluated research publications of the faculty to this Directorate through a special messenger.

All concerned authorities are requested to widely circulate this notice among all faculty members listed in the enclosed document. This will enable them to submit their publications in accordance with the aforementioned Regulations. If any other faculty members within the OMES cadre are eligible for promotion to Associate Professor or Professor but have been inadvertently omitted from the provided list, they may provide their details using the specified format.

It is made mandatory that faculty members are strictly prohibited from directly submitting their research publications to this Directorate under any circumstances. A copy of this notice should also be made available on the official websites of each college to facilitate widespread circulation among all concerned.
