ADVERTISEMENT FOR FILLING UP OF POSTS OF ASSISTANT PROFESSOR (CONTRACTUAL) IN ANESTHESIOLOGY AT SCB DENTAL COLLEGE & HOSPITAL, CUTTACK

HFW-MEI-SR-0002-2018-1532/H In pursuance of Notification No. dtd.19.01.2024 read with Resolution No.8967/H dtd.25.04.2022 of Health & F. W. Department, Govt. of Odisha, the eligible candidates are hereby invited for Walk-In Interview/Counseling for Selection of 01 (One) no. of Post of Assistant Professor (Anesthesiology) in SCB Dental College & Hospital, Cuttack on Contractual / Deputation basis in view of NMC urgency. The applicant must have acquired the required qualification for the post applied for, on or before the date of counseling. The candidates who are continuing as faculties in any of the Govt. Medical College of the state, VIMSAR, Burla or AHPGIC, Cuttack, either on Contractual / Deputation are not eligible to apply. The regular candidates under OMES cadre are not eligible to apply. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years, The details of eligibility criteria are as under.

1. VACANCY & PROGRAMME:

The vacancy is provisional and is subject to change as on the date of Walk-in Interview/counseling, Vacancies occurring after the date of counseling shall be filled up through fresh advertisement. The tentative programme will be available in the website of SCBDCH, Cuttack (i.e. https://scbdental.nic.in/)

2. ELIGIBILITY:

- i. The candidate must be a citizen of India.
- ii. Qualification: The candidate must possess MD/ MS/ DNB or equivalent degree in Anesthesiology from any MCI/NMC approved/ recognized/ permitted Medical Colleges or any other academic qualification with such additional teaching experience in the subject as may be prescribed by the NMC and as per "Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022"and "Guideline for Under Graduate Courses under Establishment of New Medical Institutions, Starting of New Medical Courses, Increase Of Seats for Existing Courses & Assessment and Rating Regulations, 2023"of NMC, in force and OMES Rules 2021.
- iii. Must have registered himself/ herself under any State Medical Council/MCl/NMC after obtaining the degree.
- iv. The above qualifications must have been obtained on or before the date of counseling / interview.

3. AGE LIMIT

The upper age limit for candidates on a contractual basis shall be less than 69 years as on the date of interview (The maximum age up to which one can serve is 70 years). N.B.: The date of Birth entered in the High school Certificate or equivalent certificate issued by the concerned Board/ Council only shall be accepted.

4. PROCEDURE OF APPLICATION

Interested candidates shall download the Application Form annexed in this Advertisement from the official website of SCBDCH (i.e. https://https://scbdental.nic.in/).

The candidate shall have to appear in person before the Convenor, Selection Committee in the Office of Principal, SCBDCH, Cuttack as per schedule and submit the application form attached to this advertisement duly filled in and photocopy of required documents and color passport photograph. He must bring the Original documents for verification without which the candidature will be invalid. After successful verification of the documents, a merit list shall be prepared and notified on the spot. Any other information shall be notified by the Convener on the website of SCBDCH, Cuttack (i.e. https://scbdental.nic.in/).

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected, and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

5. PROCEDURE OF SELECTION

- a. The selection for Assistant Professor shall be as under:
 - i. Selection will be strictly based on a merit list prepared on the basis of career marks.

Weightage for different examinations shall be as under: HSC/Matriculation- 20% of total percentage of marks secured. Intermediate Science- 20% of total percentage of marks secured, MBBS examination- 60% of total percentage of marks secured. (In case the candidate has passed PG in 2016-2017 or afterwards MBBS— 30% and PG - 30%)

- ii. One mark will be deducted from the total Career Mark for each extra attempt taken to pass the examinations.
- iii. In the case of foreign medical graduates (FMG) the marks secured in the subjects as per the NMC/MCI conducted by NBE shall be taken for calculation of merit as above. Where the candidate does not submit such mark sheet, their marks will be taken as 50%.

- iv. In case of tie it will be resolved as follows:
 - 1. "The candidate securing more marks in MBBS shall be placed in higher rank.
 - 2. In case of further tie the elderly candidates shall be placed: higher in rank to the younger."
- b. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.
- c. In case the candidate appointed to a post fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- d. All communication shall be made through the website of SCBDCH, Cuttack i.e. https://scbdental.nic.in/ No postal/ personal communication will be made.
- e. Engagement will be on the basis of merit. Appointment/ Engagement order shall be uploaded on the website of SCB Dental College & Hospital, Cuttack i.e. https://scbdental.nic.in/. The direct candidates must report before the authority of this institution within 07 (Seven) days of issue of engagement order or as may be instructed in the appointment order and the in-service candidates shall join after obtaining the relieve order from Government.

6. **TERM & CONDITIONS**

- a. The Assistant Professor (Contractual) is entitled for remuneration of Rs. 1,20,000/- per month, in addition to the above, any incentive as may be notified by the Govt. shall be allowed.
- b. The in-service candidates shall be allowed salary at par to the post in which appointed, and any incentive as may be notified by Govt. It will be guided as per the Govt. letters issued from time to time.
- c. The engagement shall be purely temporary and on year-to-year tenure basis and may be for a maximum period of four years subject to satisfactory performance. However, the Govt. reserves the right to terminate the services of the faculty with one- month prior notice without assigning any reason.
- d. All the communications shall be made through the website of SCBDCH, Cuttack i.e. https://scbdental.nic.in/. No Postal/ personal communication will be made.
- e. Selected candidates must sign an agreement as per Govt. resolution 8967/H&FW Dt. 25.04.2022 at the time of Joining.
