The applicant must have acquired the required qualification for the post applied for, on or before the date of counseling. The Direct Candidates shall be appointed on Contractual Basis and the In-Service Candidates shall be appointed on Deputation basis for a maximum period of 04 (four) years. The candidates who are continuing as Faculties in S.C.B. Dental College & Hospital, Cuttack either on Contractual / Deputation are eligible to apply for the higher-level post only. The regular candidates under OMES cadre are not eligible to apply. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years.

The vacancy is provisional and is subject to change as on the date of Walk-in Interview/counseling, Vacancies occurring after the date of counseling shall be filled up through fresh advertisement. 2. ELIGIBILITY:

- 2.1. The candidate must be a citizen of India.
- 2.2. Qualification:

2.2.1. For Assistant Professor:

The candidates must possess MDS Degree in Pedodontics & Preventive Dentistry from any DCI permitted /

approved / recognized Dental College as per DCI Guideline, 2017 / Regulation in force.

- 2.2.1.1. The Dental Graduates must have registered their Dental Qualification under any State Dental Council / DCI after obtaining the degree.
- 2.2.1.2. The above qualifications must have been obtained on or before the date of Counseling / Interview.

2.2.2. For Associate Professor:

The candidates must possess MDS Degree in Conservative Dentistry & Endodontics from any DCI permitted / approved / recognized Dental College as per DCI Guideline, 2017 / Regulation in force.

- 2.2.2.1. Must have Teaching Experience of minimum 04 (four) years after MDS in the concerned discipline from any DCI permitted / approved / recognized Dental College with Research Publications during the tenure of Assistant Professor as may be prescribed by DCI from time to time.
- 2.2.2.2. The requisite experience and other requirements for equating a Specialist as Associate Professor shall be as prescribed by DCI from time to time in force.
- 2.2.2.3. All qualifications as on the date of counselling shall be considered.

3. AGE LIMIT:

The upper age limit for candidates on a contractual basis shall be less than 69 years on the date of interview (The maximum age up to which one can serve is 70 years). N.B.: The date of Birth entered in the High school Certificate or equivalent certificate issued by the concerned Board/ Council only shall be accepted.

4. PROCEDURE OF APPLICATION:

Interested candidates shall download the Application Form annexed in this Advertisement from the official website of SCBDCH (i.e. https://https://scbdental.nic.in/).

The candidate shall have to appear in person before the Convenor, Selection Committee in the Office of Principal, SCB Dental College & Hospital, Cuttack as per schedule and submit the Application Form attached to this advertisement duly filled in and photocopy of required documents and color passport photograph. He / she must bring the Original documents for verification without which the candidature will be invalid. After successful verification of the documents, a merit list shall be prepared and notified on the spot. Any other information shall be notified by the Convener on the website of SCBDCH, Cuttack (i.e. https://scbdental.nic.in/).

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected, and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

5. **PROCEDURE OF SELECTION**

- a. The selection for Assoc. Professor and Asst. Professor shall be as under:
 - Selection will be strictly based on a merit list prepared on the basis of career marks.

Weightage for different examinations shall be as under: HSC/Matriculation- 20% of total percentage of marks secured. Intermediate Science- 20% of total percentage of marks secured, BDS Examination- 60% of total percentage of marks secured. (In case the candidate has passed PG in 2016-2017 or afterwardsBDS — 30% and MDS – 30%)

- ii. One mark will be deducted from the Total Career Mark for each extra attempt taken to pass the examinations.
- iii. In case of tie it will be resolved as follows:
 - 1. "The candidate securing more marks in BDS shall be placed in higher rank.
 - 2. In case of further tie the elderly candidates shall be placed: higher in rank to the younger."
- b. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.
- c. In case the candidate appointed to a post fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- d. All communication shall be made through the website of SCBDCH, Cuttack i.e. https://scbdental.nic.in. No postal/ personal communication will be made.
- e. Engagement will be on the basis of merit. Appointment/ Engagement order shall be uploaded on the website of SCB Dental College & Hospital, Cuttack i.e. https://scbdental.nic.in/. The direct candidates must report before the authority of this institution within 07 (Seven) days of issue of engagement order or as may be instructed in the appointment order and the in-service candidates shall join after obtaining the relieve order from Government.

a. The Assistant Professor and Associate Professor (Contractual) is entitled for remuneration of Rs. 1,20,000/- and Rs. 2,00,000/-per month respectively, in addition to the above, any incentive as may be notified by the Govt. shall be

allowed.

- b. The in-service candidates shall be allowed salary at par to the post in which appointed, and any incentive as may be notified by Govt. It will be guided as per the Govt. letters issued from time to time.
- c. The engagement shall be purely temporary and on year-to-year tenure basis and may be for a maximum period of 04 (four) years subject to satisfactory performance. However, the Govt. reserves the right to terminate the services of the faculty with one-month prior notice without assigning any reason.
