The Bidders should specifically super scribe, **“DOWNLOADED FROM THE WEBSITE”** on the top corner of the outer envelope containing the Bid. The Security deposit amount should be submitted separately. In case of any bid amendment and clarification responsibility lies with the bidders to collect the same from the website / Office of the undersigned before last date. The authority / Committee, S.C.B. Dental College & Hospital, Cuttack shall have no responsibility for any delay / omission on part of the bidder.

The quotation paper will be rejected if the bidder changes any clause or Annexure of the bid document downloaded from the website.

- II) The interested quotationer may inspect the old instruments, equipments and furnitures available in the different department of SCB Dental College during working days from 05.05.2025 to 19.05.2025 at 11 AM to 5 PM. For any clarification they may contact Prof & HOD / I/C of concern department / Hospital Manager, SCB Dental College and Hospital, Cuttack before submission of Tender.
- III) Sealed tenders , super scribing on the envelop **“ QUOTATION FOR AUCTION SALE OF OBSOLETE INSTRUMENTS, EQUIPMENTS AND FURNITURES”** should reach the undersigned on or before 11.00 A.M of Dt. 19.05.2025 through Speed Post / Regd. Post / Courier only which will be opened on the same day at 03.00 P.M. in presence of the tenderers or their authorized representatives. There is no bar for opening of the bid document if the tenderer fails to present at the time opening.
- IV) The Tenderer should enclose Bank Draft @ 10, 000 / (Rupees Ten Thousand Only) in favor of the **“Principal SCB Dental College & Hospital, Cuttack”** on any Nationalized bank at Cuttack towards EMD (non- interest bearing) along with their tender, without which the tender will be rejected.
- V) The successful bidder will deposit the total value immediately, within 7 days from receipt of the order otherwise his / her tender will be canceled and the EMD submitted by him/her will be forfeited. The successful bidder will left the items within ten days from receipt of the order, custody and safety of the Instruments and Equipments shall be the responsibility of the bidder after final receive of the order otherwise 1% of the

total value will be charged for each day or part of the day till the condemned articles are removed from the site.

- VI) The EMD of all unsuccessful tenderer will be refunded after finalization of the tender.
- VII) The EMD may be forfeited
  - a) If a Tenderer withdraws its tender during the period of interval between deadline of submission & finalization of the Tender.
  - b) In case of a successful tenderer, if the tender fails to execute the work order.
- VIII) The condemned articles will be handed over to the successful tenderer after proper receipt of the deal at the places where it is lying. It will be the responsibility of the successful tenderer / purchaser to dismantled and take delivery of the condemned articles to their destination by their own arrangement.
- IX) The tenderer should sign and put his seal on each page of the tender document i.e. up to date GST Clearance Certificate / PAN Card / Voter I.D. Card and submit the entire set along with the required amount of EMD in sealed envelope.
- X) Incomplete tenders shall be rejected.
- XI) Conditional tenders shall not be accepted.
- XII) The Principal, SCB Dental College & Hospital, Cuttack reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
